UPON hearing the counsel the Court made the following
 O R D E R

1. Issue notice, returnable on 14.10.2025.
2. Mr. Tushar Mehta, learned Solicitor General of India appears and accepts notice through his advocate on record on behalf of the Union of India (respondent no.1), Union

Territory of Ladakh (respondent no.2) and Deputy Commissioner, Leh (respondent no.3).

3. Liberty is given to the petitioner to serve the Standing Counsel for the Superintendent of Central Jail, Jodhpur, Rajasthan (respondent no.4).

4. Learned Solicitor General would submit that they would examine feasibility to serve the copy of the order of detention to the wife of the detenue, the copy of which has already been served on the detenue.

5. It needs to be observed that Detaining Authority shall ensure that the detenue receives the medical attention suitable to his condition as may be required and same shall be facilitated or extended to the detenue as per the extant Prison Rules.
